

#### TERMS AND CONDITIONS FOR THE PROMOTION:

#### PROMOTIONAL PERIOD AND PROMOTER

# **ELIGIBILITY REQUIREMENTS**

- 1. Entry into this Promotion is open to all members and visitors of Mulgrave Country Club (excluding staff of the Mulgrave Country Club and the current Board of Directors) as provided further in these Terms and Conditions. Mulgrave Country Club warrants that membership of the program does not require the entrant to agree to receive any gaming machine advertising.
- 2. To be eligible to participate in the Promotion, a person must be aged 18 years or over

# **ENTRY**

- 8. Identification considered suitable for any verification is at the discretion of the Promoter. - 11. Except as specified otherwise in these Terms and Conditions, if for any reason a winner does not redeem the prize or an element of the prize at the time stipulated by the Promoter, then the prize or that element of the prize will be forfeited.
- 12. By entering the Promotion, each Entrant consents to the Promoter using (or permitting authorised third parties to use) the Entrant's name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period of time without remuneration for the purpose of promoting this Promotion (including any outcome), the Promoter and or products/services supplied by the Promoter.

- 14. Printing and other quality control errors will not invalidate an otherwise valid prize claim.
- 15. Except for any implied condition or warranty (including any applicable Consumer Guarantee) the exclusion of which from these Terms and Conditions would contravene any statute or cause any part of these Terms and Conditions to be void ("Non-Excludable Condition"), the Promoter excludes from these Terms and Conditions all conditions, warranties and terms, implied by statute, general law or custom. Except for any liability in relation to a Non-Excludable Condition, the Promoter (including its officers, employees, contractors and agents) excludes all liability whether arising in tort (including, without limitation, negligence), contract or otherwise for any personal injury or any other loss, damage, cost, expense, damage or claim suffered, sustained or incurred (including without limitation loss of opportunity or loss of profits) whether direct, indirect, special or consequential, arising either directly or indirectly out of or in connection with the Promotion or the Prize, including (without limitation) the following: (a) any technical difficulties or

equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or Prize claim that is late, lost altered, damaged or misdirected (whether or not after receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in Prize value to that stated in these Terms and Conditions; (e) any tax implications; (f) the cancellation or postponement of an event which constitutes the prize; (g) a Prize or use of a Prize; and/or (h) attendance at or participation in the Event (if applicable).
